The undersigned Rider and Horse Owner, and their Parents/Guardians, hereby:

(1) acknowledge and agree that the decision to participate in and attend the Poplar Place Stables Hunter/Jumper Schooling Show (the "Show"), and any evaluation of the Rider's or horse's ability to safely and competently participate in the Show and in any activity or class of the Show, has been made at the sole and absolute discretion of the Rider, Horse Owner, and their Parents/Guardians, and they accept and assume full and complete responsibility for all such matters;

(2) acknowledge and agree that equestrian activities, including without limitation participation and attendance at the Show, are inherently dangerous, and that they accept and assume the inherent risks involved therein, including without limitation the risk of injury, death and damage to or destruction of the Rider, Horse Owner, other persons, horses and property, and the risk of any harm resulting from acts, omissions, or negligence of Poplar Place Stables & Eventing ("PPS"), and/or their owners, shareholders, officers, directors, members, employees, sponsors, patrons, guests, and agents, and all others related to them, or any of them ("the Released Persons").

(3) agree to waive and release, and to indemnify, defend and hold harmless, the Released Persons, and each of them, from and against any and all loss, damage, liability and injury of any kind, however caused, whether known or unknown, expected or unexpected, arising out of or resulting from participation in or attendance at the Show;

(4) agree to waive and release any rights under California Civil Code 1542, which states: "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor";

(5) grant a release to photograph, videotape, publish and/or broadcast his/her involvement in the Show;

In the event of injury to Rider, Horse Owner, and/or his/her animals, permission for emergency medical treatment is hereby granted to PPS, their doctors, veterinarians, employees, owners, members, and agents.
